Residency application in 5 easy steps

1. Carefully read the application form
2. Complete the application form and sign (on page 4 and 7) and save as a single .PDF
3. Answer the questions and attach the documents, images and urls. Save all these texts, images and urls together in a single .PDF

5. Pay the € 30,- administration fee

Answer the questions and gather all documents in one .pdf

a. Introduction to your work. Provide a clear and informative summary of your work (max 450 words).

b. Curriculum Vitae (max 4 pages). **Include a selfie in your studio.** We also appreciate the contact information of **two supporting references.**

c. An overview of completed projects (recent 5 years and max. 10 pages A4). Add a summary of your current project (max 600 words).

d. Motivate how a residency at SEA supports the development of your work. Outline how the residency will make a difference to your practice (max 400 words).

e. Describe your residency project plan. Be as specific, realistic and detailed as possible include an anticipated schedule (max 3000 words).

f. Add details of any forthcoming projects. Highlight key projects over the next year (up-coming collaborations, exhibitions, publications, etc.) with details of partners involved (max 3000 words).

g. Add Images and Urls (5 and 10 images or url's in case of video or projects). The title of the images must contain your surname and title of the project/work and year. (for example: Johnson-notitle2015-01.jpg)

SEA Fellowship worth up to € 8645

There are 2 fellowship grants available for selected admitted applicants. The Fellowship is meant to cover the costs for the residency at SEA foundation, up to a maximum of 12 weeks.

Research grant € 200,- per week

Grantees receive € 200 euro per week when in residence. For example, to cover the costs for additional studio assistance or additional residency materials.

Stipend production up to € 1500

Awardees may use the production budget to pay for the costs in connection to the execution of a concept or public activities like an exhibition, a series of talks or lectures.

Studio

The well equipped live/work studio of over 100 m², with it's mezzanine bedroom en-suite sleeps max. 2 persons and it is purposely build with a perfect northern daylight orientation and garden terrace. Bespoke mentoring up to 4 hours a week, peer-to-peer talks, guidance, technical advice, Wi-Fi, use of workshop, breakfast, outings and bike are also included.

Costs for the resident:

- Travel costs
- Insurance costs (viable health and liability insurance)
- Personal spending

Award-holders are required to live at the AiR Tilburg designated studio throughout the period of the award.

Self-funded costs for the residency

Studio costs are € 595 euro (1 person) or € 665 euro (2 persons) or part thereof. More information in the *letter of invitation*.

SEA FOUNDATION GENERAL INFORMATION FOR RESIDENTS

You are entrusted with 24-hour access to the house, the garden and your studio. Please keep to the house rules and act in a responsible and welcoming manner to the other long- and short-term residents.

ARRIVAL

- Check-in: Weekdays Monday – Thursday from 2:30 – 7 pm onwards. Other dates and times by prior agreement, for example due to international flights coming in.
- Check-out: On the day of departure before 11:00 am, later times by prior arrangements only.
- Upon arrival you are requested to show a copy of your identity papers (i.e. passport or identity card), as well as to complete a form about your dietary preferences.
- Upon your arrival, you will be asked to sign for the four keys. One for the front door, one for your studio, one for the garden gate and one for the bike on loan.
- In case of loss of one or more keys, you will be charged for the replacement: € 60,- for the certified front door key and € 20,- for any of the other keys. Stolen or lost bicycles must be refunded by the resident, who is also responsible for reporting the theft to the police. In case of repairs to your bike, it needs to be done at your own costs.
- At the time of arrival, goods and luggage can be dropped at the reception, before taking them to the studio.
- There is free parking nearby. Cars are left at the owners own risk
- All-linen and towels are provided.
- The laundry room is equipped with a washing machine and laundry products. You can notify housekeeping whenever you want to use these facilities.

HOUSE RULES

- Pets are not allowed.
- Alcohol abuse or the use of drugs, will result in the immediate termination of your residency.
- Smoking is strictly prohibited in all buildings. Smoking in the garden is allowed.
- We engage in using materials sparingly and reduce waste. The wastewater is treated in a water treatment plant. Never discharge acids, paint and fluids into the drain.
- Paper, glass, plastic and tin cans must be sorted for recycling. Please put them in the corresponding containers and follow the guidelines.
- Former residents and applicants will receive the newsletter and open calls that are sent out. If you do not wish to receive this information, please inform the Residency Coordinator.

SAFETY

- Check the escape routes of the building and make sure you know where the first aid kits are located.
- In case of problems or defects, please notify the staff immediately.
- Breakage should be reported to the staff immediately.
- Take good care of keys entrusted to you.
- Please keep the front door locked at all times.
- In case of emergency call 112.
- In case of lesser public emergency issues call 0900-8844.
- Should the fire alarm go off, please proceed to the exit in a calm and orderly manner.

DEPARTURE

- We expect you to make your arrangements regarding the planned time of departure known to the residency coordinator at least three days before you leave. Your live/work studio should be left in the condition you found it. You may either clean your live/work studio yourself, or have it cleaned by housekeeping, in which case a cleaning fee of € 50,- applies.
- Please settle your account of the purchases made during your stay on the morning of departure.

FINANCES

After the confirmation of your residency, you will receive an invoice from SEA Foundation, indicating a € 450 euro deposit. The deposit will be returned to you within two weeks after completing your residency. This deposit is to secure your place in the program. Since we have to invest time and effort into the preparation of each residency. The deposit is to cover our expenses, should a resident decide to forfeit their place before the start of the residency, or cancel their residency prematurely. Self-funded residencies will be invoiced within 6 weeks of admittance.

If you are unable to attend the residency, please inform us immediately of your cancellation. Cancellations attract an administration fee of € 50 euro.

- If you cancel more than four months before the start of the residency we will refund your payments minus the cancellation fee.
- If you cancel within four months before the start of your residency we will refund 50% of your payments. The deposit will be refunded.
- In case of an urgent reason, a full refund can be requested, and may be granted for special reasons and in special circumstances.
- Applicants who cancel, lose their place in the residency program. Should you wish to join the programme at a later date, please submit a new application.
- Payment of invoices should be made no later than 30 days from the date of the invoice.

ACCIDENTS AND DAMAGES

During the residency SEA Foundation is not liable for:

- Accidents in the house, the studio's or in it's grounds.
- Theft or loss of personal property, including works of art belonging to the artist.
- SEA Foundation is not liable for damages, theft or accidents to vehicles.
- Damage arising from the use of equipment, materials and products that are provided by SEA Foundation.
- Damage due to alleged errors made by SEA Foundation employees, volunteers or free-lance advisors.

During the residency the resident is liable for:

- Any theft, damages or injuries inflicted by the resident to any property of SEA Foundation or third person's properties during the residency period. The resident is fully liable and has full responsibility for any loss or damage that incurred. The residency agreement will be dissolved and terminated with immediate effect. The resident is no longer entitled to claim granted support in concurrence to the research grant and the production budget will be waived.

INSURANCES

- SEA Foundation advises all residents to take a suitable travel, liability and health insurance.
